Letter from our Executive Director



In 2020 many things felt out of our control, so Special Olympics New Mexico focused what we could control within our organization instead. Our challenge was to stay mission driven and athlete focused during a pandemic. The pandemic left many of our athletes feeling fearful, bored, and lonely. Without in-person training, Games, or events, it became apparent that Special Olympics athletes were facing the serious consequences of deteriorating health, lack of personal achievement, and social isolation. Using a digital platform, Special Olympics New Mexico was able to pivot by offering Virtual Games, Fitness Challenges, and Health and Wellness programs. Hundreds of our athletes remained engaged virtually through bingo nights, craft nights, and even a Zoom Halloween Dance. Over time, the pandemic not only challenged

our way of thinking but broadened our way of doing.

As weeks rolled into months of sheltering in place, the Special Olympics spirit found ways to shine in 2020. The Law Enforcement Torch Run “Flame of Hope” burned brightly in the hearts of New Mexico’s Law Enforcement officers early in the pandemic. Although there was no traditional State Summer Games, Opening Ceremonies, or lighting of the Special Olympics cauldron, more than 300 officers raised dollars and awareness on behalf of our athletes and families during the 2020 Virtual State Relay Run. New Mexico’s “Guardians of the Flame” raised \$136,000 on our behalf in 2020. The perseverance of our torch runners brought hope for the day Special Olympics athletes would return to play and our Games would go on.

In September 2020, the Executive Committee of the Board of Directors of Special Olympics Inc. added a mandate to the Special Olympics General Rules requiring each Special Olympics Program in the United States to develop a Diversity, Equity, and Inclusion (DEI) policy. The Special Olympics New Mexico Board of Directors responded by embracing the broad definition of diversity, committing to eliminating barriers that prevent participation, and seeing every human being as a gift to be valued. I am proud to share that Special Olympics New Mexico now has an official DEI Statement and hiring policy. We will continue to invest time and resources as a sports organization whose culture is and always has been recognized as a culture of inclusion.

In closing, during the very different and often difficult pandemic year, all of us found strength and endurance by connecting with Special Olympics athletes. Special Olympics athletes have a way of leading by example, and we witnessed how capable they were when facing adversity: no anger, no agenda, and no blame. By continuing to share the best of themselves through a very challenging time, Special Olympics athletes brought out the best in us. Special Olympics New Mexico stayed committed to the mission by creating meaningful opportunities for our athletes. We can’t wait to be with each of them again.

Virtual Sports

The State Poly Hockey Championships were held in Farmington in February 2020, and in March 2020 Special Olympics New Mexico realized the need to pivot to support Special Olympics athletes as they remained at home during the pandemic. The Special Olympics New Mexico Program staff created Virtual Games seasons to mirror the sport seasons that take place in a typical year. Virtual Games seasons took place for 8-10 weeks at a time to allow ample training time. Special Olympics athletes who participated in the Virtual Games trained and competed in sport skills and sport activities from home and submitted their scores to the State Office. Fitness was added as a new sport in 2020 to support Special Olympics athletes in training their overall strength, endurance, and health.

After each Virtual Games season ended and final scores were submitted, Virtual Drive-through Awards ceremonies were held across the state. Law Enforcement Torch Run law enforcement officers volunteered their time to distribute awards and medals to each Special Olympics athlete who participated.

Special Olympics Unified Champion Schools®

2020-2021

Special Olympics Unified Champion Schools® is a strategy for schools Pre-K through university that intentionally promotes meaningful social inclusion by bringing together students with and without intellectual disabilities (ID) to create accepting school environments. This 3 component model includes: Special Olympics Unified Sports®, inclusive youth leadership, and whole school engagement.

When New Mexico schools moved to remote learning in 2020, it allowed us to focus on fitness and the inclusive youth leadership aspect of our program. We sent out resources to teachers and students including backpacks filled with basic sport and fitness equipment, virtual lesson plans, and links to various online content from our partners. Many schools organized virtual “hangouts” where students with and without disabilities could meet up, learn new skills, and interact with one another in a safe way. The virtual meet-ups allowed for clubs to continue social interaction and focus on social and emotional skills.



We utilized virtual platforms including Zoom to host a “Livingroom Olympics” competition that has students complete fitness skills and tasks from home. This opened us up to larger, statewide competitions which is something we hadn’t done before in New Mexico’s Unified Champion Schools. While these competitions were not at the level we normally see with fans in the stands, music, and whole day celebrations, they were a way for students to remain active and continue to improve physical skills.

Despite ongoing challenges, we learned to adapt and serve our students in new, meaningful ways while fostering student leadership as students stepped into roles typically reserved for adult liaisons. We learned more about who our students are as individuals and not only as athletes. The lessons learned will help us to continue to grow the program and create more opportunities for students to lead as we move forward.

“This year was extremely challenging for everyone in the educational field but especially hard for students. I think the Unified Champion Schools program allowed for a tiny bit of normalcy in an otherwise crazy time. The program did not look like it normally does, but I think just being able to see and interact with people in a less structured setting really helped my students and let them know that they were not alone.”




Special Olympics Health

In the beginning of 2020 SONM dedicated a full-time staff member to Health and Wellness, solidifying our commitment to improving the lives of New Mexicans with disabilities. As we navigated the effects of the COVID-19 pandemic, SONM Health and Wellness implemented several programs to help our athletes stay active, healthy, and connected with our Special Olympics community through virtual health and fitness opportunities.

In the spring of 2020 we created a Health and Wellness Facebook Group to provide athletes with tools to stay active and healthy at home while encouraging them to continue training in the absence of practices and competitions.

We hosted 3 virtual fitness challenges and incorporated fitness activities in our virtual competitions. During the challenges we posted daily activities on our Facebook page creating opportunities for our athletes to connect and encourage each other.



2020 Health & Wellness Highlights

- Health Messengers program established and 2 Special Olympics athletes trained as Health Messengers
- SONM wins the Southwest Border Battle, a virtual health focused challenge and friendly competition with SO Arizona, SO Colorado, and SO Utah
- Health & Wellness Facebook Group created to share weekly health focused activities with more than 300 members and participants.
- 450 Fall Fitness Workbooks distributed, providing 8 weeks of daily activities including exercise information, health education, and weekly activities to keep mind, body, and spirit active.

New Mexico Law Enforcement Torch Run

The pandemic brought many challenges to the Law Enforcement Torch Run (LETR) fundraising and community policing program in 2020. As we navigated through the health and community guidelines in place, our first priority was for agencies to focus on officer health and safety, and secondly, to remain hopeful in our fundraising efforts to ensure our “Flame of Hope” torch never lost its light for our athletes.

While we eventually had to cancel agency fundraising activities that involved gatherings of more than 10 people, our agencies hosted online Agency Fundraising Campaigns and partnered with local businesses—deemed essential by the state of NM—who could raise funds using our Torch Icon Campaigns. Although the State Summer Games was canceled, we held a modified, virtual LETR State Relay Run, where individual officers from over 40 agencies carried the Flame of Hope torch separately within their communities to raise funds and awareness for Special Olympics. Social interaction is key for Special Olympics athletes, and law enforcement officers personally visited Special Olympics athletes across New Mexico to check-in and remind each athlete that they are valued and not forgotten.

We are thankful for our LETR officers, who truly live our LETR Oath: “I will protect, defend, and befriend all those who seek the joy of Special Olympics sport, and I will always be a Guardian of the Flame of Hope.”


2020 Financials


Funding Sources: \$1,512,993
