

TRAINING AND COMPETITION - THE SERVICES PROVIDED BY SPECIAL OLYMPICS NEW MEXICO (SONM) IS THAT OF OFFERING 3700 CHILDREN AND ADULTS WITH INTELLECTUAL DISABILITIES THE OPPORTUNITY TO TRAIN AND COMPETE YEAR-ROUND IN 12 SPORTS AT THE AREA AND STATE LEVEL. DUE TO COVID 19, SPECIAL OLYMPICS WAS ONLY ABLE TO OFFER TWO FACE-TO-FACE COMPETITIONS, AS WELL AS VIRTUAL PROGRAMMING INCLUDING FITNESS CHALLENGES, SOCIAL ENGAGEMENT ACTIVITIES, AND WELLNESS PROGRAMS. 1,699 SPECIAL OLYMPICS ATHLETES PARTICIPATED, AS WELL AS 93 CERTIFIED COACHES.
